The Town Council does not currently meet the two criteria requirements in accordance with Section 8 of the Localism Act 2011.

The council has a Clerk who holds a sector specific qualification (in this case CILCA as of the 3^{rd of} February 2022) however, the number of elected Councillors at the last ordinary election must equal or exceed two thirds of the total number of Councillors. The total number of Councillors is 15 and currently there are 9 who were elected at the last ordinary election which is less than two thirds of the total number.

k. To approve the one spine point, pay increase from 24 to 25 for the Clerk in accordance with the model Slcc contract upon completion of the Cilca qualification with effect from the 1^{st of} March 2022.
