The members of the public made representations about the planning applications concerning New Road. They raised concerns about the Parking being reduced by the proposal to build 3 apartments above the NISA shop. 6 of the 12 spaces will be taken for residents of the apartments and as such reduce the available parking for customers. There are three applications for builds in New Road. The parking is not good here and congestion is a problem especially around school times. Cllr Wright offered to arrange a meeting between the Residents of New Road, the Children's home, the Police and the Council and the Public. The members of the public present indicated they would like a meeting to take place.

The Public also raised concerns about the 6 windows from the NISA build which look directly over the road onto number 53 Bulford Road.

The Public also raised issue with the Outbuilding at number 2 New Road stating that this was listed as provision for a classroom in the garden, but it does not have enough windows for an educational building. The residents are concerned about the use of this building.

There were concerns raised about the new build especially around the disruption of the build with the already cramped parking conditions.

A member of the public made representations about the Plough's retrospective planning application raising concerns about the wildlife in particular bats and the noise and lighting. The increase in volume of noise as patrons are sitting outside under the new pergolas. The garden area has changed he said from being used infrequently to constant use.
